## ACTION LEARNING SETS

## Funded Clinical Supervision Action Learning Sets (ALS) for Nurses (FEW SPACES REMAINING)

The Cheshire and Merseyside Training Hub is offering to support one nurse per PCN to develop clinical supervision skills through action learning sets (ALS). Participants will be trained and supported, bimonthly over 6 months, to become an ALS facilitator. Our intention is that the facilitators will then run ALS groups bi-monthly over a six-month period for a group of nurses in their PCN.

## **Funding**

Funding for a half day's ALS facilitator training for each nominated nurse. Additionally, £700 will be paid to the PCN/practice to allow the nurse to attend bi-monthly ALS for 6 months and then facilitate bi-monthly ALS within their PCN for a further 6 months.

### Enhanced clinical practitioner for general practice

Following employer demand scoping HEE are pleased to be supporting an employer led task and finish group to utilise Enhanced Clinical Practitioner (ECP) apprenticeship for general practice nursing (GPN). The group will be working to ensure that the ECP apprenticeship can be delivered in a contextualised way to train general practice nurses, aimed at those with some experience to develop their skills in long-term condition management and non-medical prescribing. Additionally, if supported by local need and demand, other modules could be provided, such as mental health, women's health or minor injuries. We envisage this course to have some core modules such as non-medical prescribing, Clinical Leadership and Research in Health, as well as a picking list of modules for specific clinical skills relevant to practices, such as Diabetes Management, Respiratory Diseases, Minor Illnesses or Sexual Health. The length of the apprenticeship would be 12-18 m depending on modules selected. The first meeting on the group will be on Thursday 27th April 2023 13:00 – 14:00, where stakeholders and partners will meet to agree the tender and course specification for the ECP (GPN) apprenticeship course.

## **Public Sector Reporting**

The deadline for public sector reporting on the digital apprenticeship service is 31st May 2023. The new data request will no longer ask for information on the actions taken to meet the public sector target as this came to an end on 31st May 2023. The refreshed data request will increase transparency and enable comparison between organisations. The data request will include organisational headcount, total number of apprentices and apprentices as a percentage of headcount.
