Cheshire & Merseyside PC Physician Associate (PA) Preceptorship Programme

We are pleased to announce that we will be running the 4th cohort of the Cheshire and Merseyside Primary Care Physician Associate (PA) Preceptorship Programme. This offer is available to both newly qualified PAs or PAs transitioning from another area (i.e. moving from an Acute Trust) and working in primary care in Cheshire and Merseyside. The start date for Cohort 4 is on the 3rd May 2023.

HEE are in the process of releasing the required application forms so that practices can claim for the £5000 funding for having a PA on the programme. The HEE £5,000 preceptorship funding is for PCNs to liaise with the PA practices. Upon successful applications, practices are to complete the application form to ensure the funding can be provided. We will be in touch once those application forms are available.

In the meantime, for a PA apply for a place please complete the <u>linked form</u> by 1st May 2023. Applications after this date will not be accepted if all spaces have been filled. We will keep them on a reserve list should there be a 5th cohort in the future.

Action Learning Sets (ALS)

Funded Clinical Supervision Action Learning Sets (ALS) for Nurses (FEW SPACES REMAINING)

The Cheshire and Merseyside Training Hub is offering to support one nurse per PCN to develop clinical supervision skills through action learning sets (ALS). Participants will be trained and supported, bi-monthly over 6 months, to become an ALS facilitator. Our intention is that the facilitators will then run ALS groups bi-monthly over a six-month period for a group of nurses in their PCN.

Funding

Funding for a half day's ALS facilitator training for each nominated nurse. Additionally, £700 will be paid to the PCN/practice to allow the nurse to attend bi-monthly ALS for 6 months and then facilitate bi-monthly ALS within their PCN for a further 6 months.

Enhanced clinical practitioner for general practice

Following employer demand scoping HEE are pleased to be supporting an employer led task and finish group to utilise Enhanced Clinical Practitioner (ECP) apprenticeship for general practice nursing (GPN). The group will be working to ensure that the ECP apprenticeship can be delivered in a contextualised way to train general practice nurses, aimed at those with some experience to develop their skills in long-term condition management and non-medical prescribing. Additionally, if supported by local need and demand, other modules could be provided, such as mental health, women's health or minor injuries. We envisage this course to have some core modules such as non-medical prescribing, Clinical Leadership and Research in Health, as well as a picking list of modules for specific clinical skills relevant to practices, such as Diabetes Management, Respiratory Diseases, Minor Illnesses or Sexual Health. The length of the apprenticeship would be 12-18 m depending on modules selected. The first meeting on the group will be on Thursday 27th April 2023 13:00 – 14:00, where stakeholders and partners will meet to agree the tender and course specification for the ECP (GPN) apprenticeship course.

Public Sector Reporting

The deadline for public sector reporting on the digital apprenticeship service is 31st May 2023. The new data request will no longer ask for information on the actions taken to meet the public sector target as this came to an end on 31st May 2023. The refreshed data request will increase transparency and enable comparison between organisations. The data request will include organisational headcount, total number of apprentices and apprentices as a percentage of headcount.
